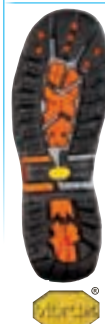

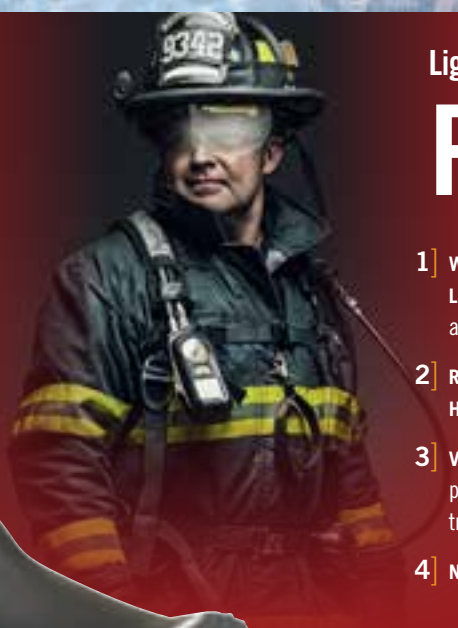

This warranty covers normal use only of the Products. Thorogood Shoes will not assume responsibility for any failure of the Products incurred by misuse, abuse, neglect or exposure to a substance or an environment that degrades the Products. Normal sole wear of the Products is not considered to be a defect in material and workmanship.

Products considered to be defective must be returned to the Authorized Seller from which the Products were originally purchased or issued with the original purchase receipt or issuer's invoice record. Our policy is to honor Product warranties only on Products purchased from an Authorized Seller of Thorogood® Products and only when accompanied by the original purchase receipt or proof of purchase. If Products are purchased from an unauthorized seller this limited warranty will not be valid.

Defective Products will be repaired or replaced at the discretion of Thorogood Shoes. Any replacement will be for the same style and size of the returned defective footwear Products.

This is a limited warranty. The obligations set forth in the preceding paragraphs are Thorogood Shoes' sole obligation and the purchaser's exclusive remedy. Thorogood Shoes makes no other express warranty. Any implied warranty of merchantability or fitness for a particular purpose that may be applicable to the Products is limited in duration to the duration of this limited warranty.
